CMSA COMPANY MEMBERSHIP PROGRAM

Welcome to CMSA's Company Membership Program. This program allows you to purchase multiple individual membership and save dollars by buying in volume. Only through this program may you transfer individual memberships to another employee, should one of the members on the account leave your employment or transfer to another area of the company. Regular Individual Memberships do not allow you the opportunity to transfer and the membership stays with the member until the expiration date.

To facilitate meeting your company's case manager and health care management educational, networking and professional association needs, your company will receive multiple discounted memberships as checked on the front of this application.

The Sponsoring Company can receive:

From 5 – 50 company individual memberships, depending on the needs and location of your company. You can now save from 13 – 27% on membership dues. *The more you sign up, the more your discount.* Since the Company Individual Members are transferable, more discounts can be recognized during the year as employees leave your organization and new employees are transferred into these open slots.

INSTRUCTIONS

- Fill out this Company Membership Application and send to CMSA with the corresponding payment for the level of company membership you have selected. Once CMSA processes your application, a welcome email will be sent to the Contact of the account with instructions on adding Company Individual Members through CMSA's Online Company Portal.
- Online, you will be able to invite specific employees to complete an online Company Individual Member Application. You will be able to monitor who has completed their application and which are still pending.
- A Company Individual Member Application must be filled out by each individual member in order to be accepted as a current member of CMSA and to begin receiving their Individual Member Benefits.
- Company Individual Memberships are paid for and owned by the company. If the company wishes to change the name of one or more individual memberships due to employee turnover or transfer, the Contact of the account simply logs into the CMSA Company Portal to remove or replace a member on the account.
- Company Individual Memberships will run and expire concurrent to the company membership. Payment for renewing company memberships must be received by CMSA prior to the expiration date for Company Individual Memberships to remain active.
- Company contact person, as listed on this company application, may also change the names of the Company Individual Memberships at the time of renewal. If no changes are made at the time of renewal, all current Company Individual Memberships will remain in effect for next year's membership.
- Company contact person may be changed by sending a written request to cmsa@cmsa.org.
- All Company Individual Members are required to join CMSA National and may join one local chapter.
- Dues for one chapter affiliation is included with each Company Individual Membership. If Company Individual Members wish to join more than the allotted one, individual or company contact must contact CMSA for an invoice on the additional chapters.
- Each Company Individual Member will receive an email Welcome confirmation once their online membership application is completed.
