### OUR VISION

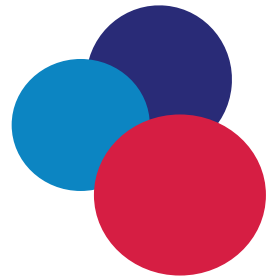

### Margaret Leonard Public Policy Grant (MLPPG)

**Grant Purpose:** Promote public policy awareness on professional case management practice by effectively communicating and building relationships with legislators, regulators or healthcare agencies at the local, state, or national level to advocate case management public policy topics supported by CMSA.

**Grant Support by Peggy Leonard:** \$5,000 donation annually for 5 years

## Case Management Awards

**Awards:** Case Management Practice Improvement Award (CMPI), and Case Management Research Award (CMR)

**Purpose:** Recognize an individual, group, or organization that uses findings from a research or quality/performance improvement initiative for innovation in the advancement of case management practice and/or improved client outcomes.

#### These awards have been established to:

- Honor successful efforts to promote evidence-based case management practice;
- Acknowledgement exceptional efforts to research best practice innovation that help quantify and define outcomes in case management;
- Encourage activities which aim to advance case management; and
- Recognize innovation to foster evidence-based practice components defined by the *CMSA Standards of Practice for Case Management*.
